¹ The FY 16 Omnibus and FY 17 Omnibus require at least \$10 million for both General Dentistry programs and Pediatric Dentistry programs. The FY 17 Omnibus awards "an additional \$800,000" to the Dental Faculty Loan Program grants initially awarded in FY 2016. The FY 18 House Committee report language requires at least \$10 million for both General Dentistry Programs and Pediatric Dentistry Programs, and \$1.7 million for Dental Faculty Loan Repayment program.

² The House Committees required \$8.9 million for the interprofessional Graduate Psychology Education (GPE) Program

³ The FY 2017 Labor-HHS bill transferred the Behavioral Health Workforce Education and Training Program from SAMHSA to HRSA as proposed in the Administration's FY 2017 budget request.

⁴ The FY 17 Omnibus report direct that the public health and preventive medicine funding go to the Public Health Training Centers program and the Preventive Medicine Residency with Integrative Health Care Training program, and not to the Integrative Medicine Program.

⁵ The FY 18 House Committee spending bill eliminates funding lines for the Title VIII Advanced Education Nursing; Nurse Education, Practice, and Rention; Workforce Diversity; and Nursing Faculty Loan programs, and consolidates the programs into a new line named "Nursing Workforce Development."

⁶ The FY 18 Senate Committee report language creates a new Screening and Treatment for Maternal Depression program as authorized in Section 10005 of the 21st Century Cures Act (P.L. 114-255).
